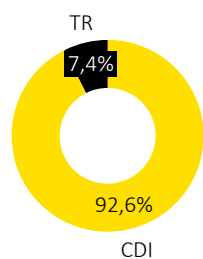


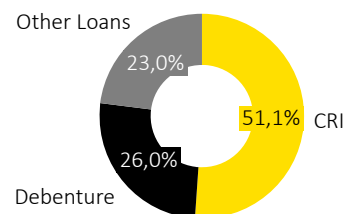

Indebtedness – 2Q25 Debt Profile

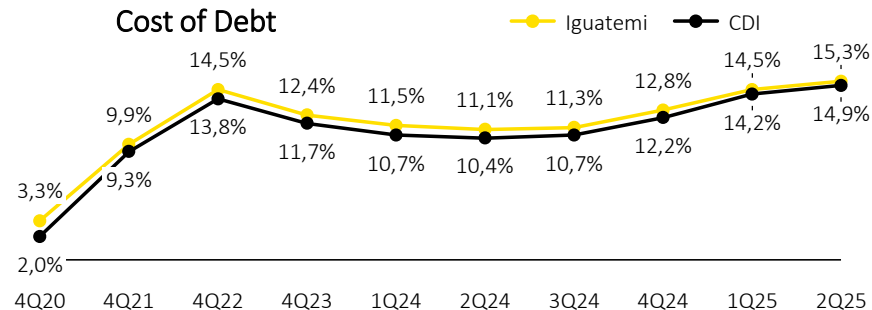
Debt breakdown by index



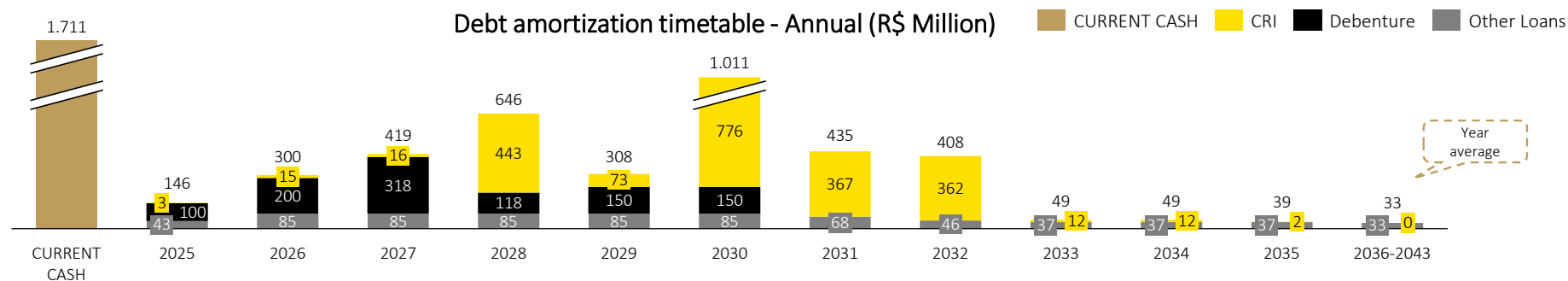
Debt breakdown by type



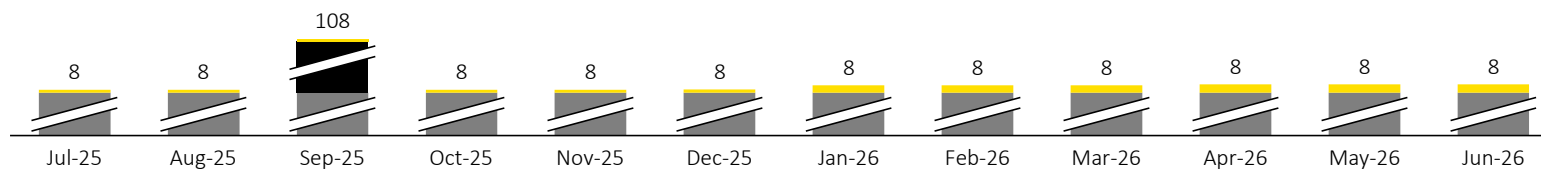
Cost of Debt
