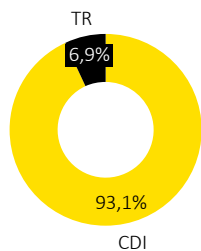


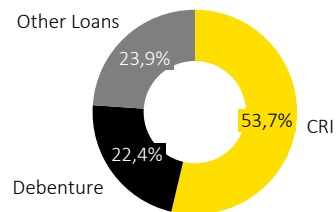

Indebtedness – 1Q26 Debt Profile

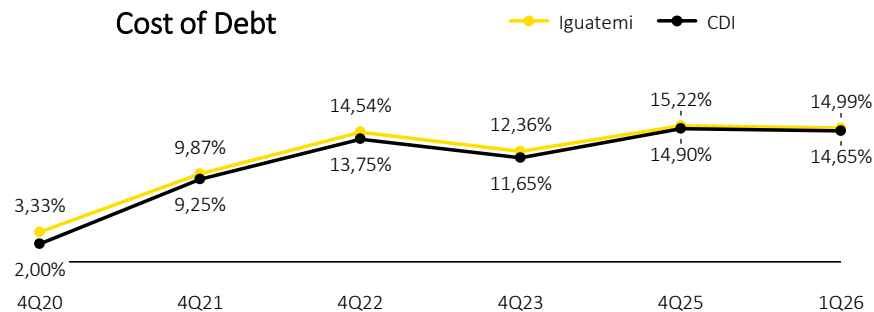
Debt breakdown by index



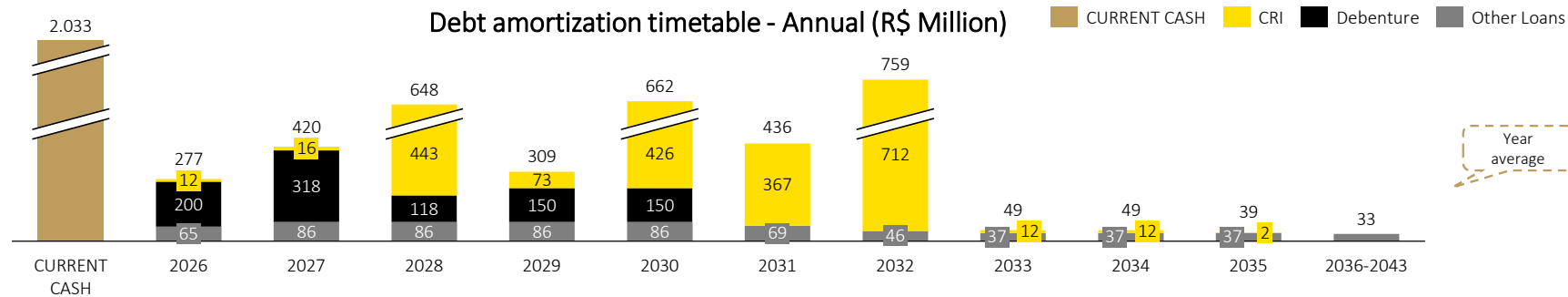
Debt breakdown by type



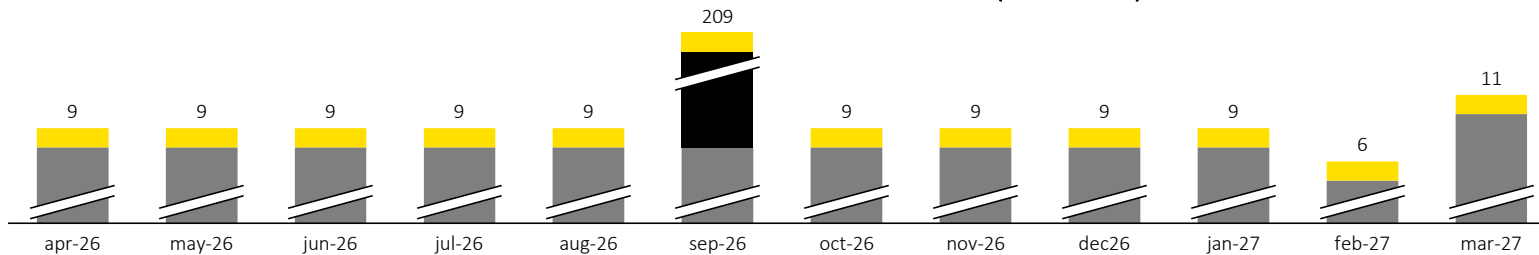
Cost of Debt
